### Item #5: Selection of Projects for Round 2 of the Carbon Reduction Electric Vehicle Charging Infrastructure Program

OKI is responsible for soliciting transportation projects eligible for OKI-allocated federal transportation funds to be included in the Transportation Improvement Program (TIP). In March 2024, OKI announced a second funding round for projects related to the acquisition and installation of publicly accessible electric vehicle charging infrastructure. The source of federal funds will be the Carbon Reduction Program (CRP). A rating process for new projects was developed, OKI staff solicited project applications, and the rating process was applied to the applications. Prior to presentation to the OKI Board of Directors, the proposed projects and ratings are presented to the Intermodal Coordinating Committee. The Intermodal Coordinating Committee considers the issue and makes a recommendation to the Executive Committee. The resolution lists the projects selected, along with their associated federal funding award and local match requirement.
