### Item #4: Resolution Authorizing a Contract Extension with Consultant for Developing a Greenhouse Gas Inventory for the Cincinnati OH-KY-IN MSA

# Item #5: Resolution Authorizing a Contract Renewal with Consultant for Maintenance Services of ORBCS

Traffic data is a key element in the analysis of existing conditions and the validation of OKI's Travel Model. Traffic data is also required for corridor studies and engineering analyses. OKI currently owns and operates radar traffic data collection units at the seven Ohio River Bridges in the OKI region. OKI seeks to retain professional services for maintenance, repair, and calibration services for the entire OKI traffic data collection system which consists of seven locations with fifteen units.

### Item #6: Resolution For Authorization To Enter Into a Contract With Consultant For Professional Services For Traffic Data Collection

Traffic data is critical to OKI staff, OKI partner agencies, and practitioners in the region in various studies and programs. OKI conducts traffic data collection when the UPWP allows. Traffic data collection to be conducted in Fiscal Year 2025 comprises two projects: (1) vehicle volume and classification counts on selected freeways and arterials; (2) pedestrian and bicycle counts at selected intersections and roadway segments. A qualified consultant or a team will be selected through a quality-based selection process. The final selection will be made on October 10, 2024, and data collection will immediately follow.
