Item #6: SFY 2026 Ohio Water Quality Areawide Funding Agreement 604(B)

The FY 2026 Ohio EPA areawide water quality planning agreement includes federal pass-through funds in an amount of \$107,314.29 under Section 604(b) of the federal Clean Water Act. OKI will develop a scope of services which details the water quality management planning activities that it will undertake in Ohio during SFY2025. The total cost for these activities would not exceed \$107,314.29.

Item #9: Adoption of FY 2026-2029 Transportation Improvement Program

The OKI FY 2026-2029 Transportation Improvement Program (TIP) is a four-year listing of surface transportation projects proposed for federal, state and local funding within the OKI region. The TIP is a prerequisite for the use of federal funds and represents the short-range programming document to complement OKI's 2050 Metropolitan Transportation Plan. A new TIP is adopted every two years. The Draft FY2026-2029 TIP was made available for public comment from March 10 – April 9 and a summary of comments will be provided to the Board prior to adoption.

Item #10: Resolution Authorizing a Contract with Consultant for Surveying Residents of Select Areas and Populations -FY25 (Ohio) (Revised)

This updates the title, scope, and timeline on a survey previously approved. Ohio authorized some FY 25 PL funding to conduct a 1st-of-its-kind survey of elderly, low income, disabled, and zero car Ohio residents on their transportation needs and preferences. The survey aims to ensure OKI stays on the cutting edge of efforts in transportation. OKI plans to have the consultant begin work in April of 2025 and complete work by December 31, 2025. This is an update from the previous EJ language and redefines the survey to ELDO communities, expanding the work timeframe to the end of year due to the changes.
