BOARD BASICS 2025



The Board of Directors is comprised of 118 members representing elected officials, business, and civic leaders. Also represented on the Board are planning commissions, chambers of commerce, public transit authorities, state departments of transportation and environmental organizations.

The OKI Executive Committee is a subset of the Board of Directors and has the authority to make all policy decisions for the Board of Directors. The Board meets quarterly, and the Executive Committee meets in the remaining months to discuss agency programs, establish policies, adopt plans, and resolve issues. Executive Committee members are permitted to have alternates per OKI's Articles of Agreement and By-Laws.

The Board's organization, strength and vision enable the Council to effectively address regional transportation, environmental and economic issues. Through ongoing collaboration, facilitated by the OKI Board of Directors, a wide range of agendas, priorities and solutions are focused into a viable plan of action that generates measurable results.

Meetings*: <u>Board of Directors</u> meets on the second Thursday of January, April, June, and October at 10:30 a.m. in the 4th floor boardroom in the Sawyer Point Building.

<u>The Executive Committee</u> meets on the second Thursday of February, March, May, July, August, September, November, and December at 10:30 a.m. in the 4th floor boardroom in the Sawyer Point Building.

Voting: All Board members can vote at the January, April, July, and October Board of Director's meetings. Those board members that are also on the Executive Committee members are permitted alternates and alternates can vote in the absence of the member at Executive Committee meetings. A board member that is not on the executive committee does not have an alternate per OKI's Articles of Agreement. Please raise your hand/placard and state your name when making a motion or second.

Microphones: When making comments to the group during meetings, please speak up and project your voice upward. The microphones are in the ceiling of the boardroom.

Meeting Materials: The agenda, meeting materials and finance officer's report are emailed to members using the Constant Contact platform the Thursday before the meeting date. Committees: The Budget Committee is composed of the funding Members of OKI. The Intermodal Coordinating Committee (ICC) is the technical committee that makes recommendations to the Executive Committee and Board of Directors. Other committees include the Environmental Justice Advisory Committee, Land Use Commission, and various other committees to conduct transportation studies. Parking: The Sawyer Point Building management has agreed to temporarily provide complimentary parking for OKI Board members. Please park in our "West" lot, directly outside of the building's primary entrance.
