

CALL TO ORDER

Mr. Adam Goetzman, Chair called the meeting to order at 9:32 a.m. He welcomed everyone to the May ICC meeting.

APPROVAL OF APRIL 9, 2024 ICC MINUTES

Mr. Adam Goetzman, Chair asked if there were any corrections or amendments to the April 9, 2024 minutes. There being no changes. Mr. Beck moved to approve the March 12, 2024 minutes. Mr. Miller seconded the motion, motion carried.

APRIL BOARD OF DIRECTORS ACTIONS

Mr. Adam Goetzman, Chair stated the April Board of Directors meeting minutes are for information only.

TRANSPORTATION PLANNING PROGRESS REPORT

Mr. Adam Goetzman, Chair asked the committee members to review the monthly progress report for April. There being no comments, the progress report for the Transportation Department was accepted.

OKI TRANSIT ONBOARD SURVEY PRESENTATION

Ms. Ting Zuo, OKI Staff and Mr. Fred G'Sell, Vice President of Field Operations for ETC Institute shared OKI's transit onboard survey. Approximately every 10 years, OKI collects travel behavior data from people who use transportation systems in the Cincinnati region and the data is used to update the region's travel demand model and improve transportation planning. This year's effort involved an OD Survey covering all fixed-route services across the region and O2O Counts for select highest volume routes. He mentioned both surveys were conducted during from late January through early March.

OKI fully incorporated all best practices recommended by the FTA and this data clearly demonstrates the importance of transit service to the region's economy. He mentioned most riders (70%) are employed either full or part-time. Work is the number one reason people use transit (18% Origin and 21% Destination, both second highest place types other than home). Without transit, most of these employees could not get to work (56% of riders do not have a household vehicle, 82% could not have used a household vehicle for trips, and 59% do not have a valid driver's license).

2050 METROPOLITAN PLAN UPDATE

Dr. Elizabeth Niese, OKI Staff provided a summary of results that OKI received a total of 2,253 surveys with 2,232 responses from individuals that live or work in OKI region and 55% of the respondents live and work in the same county. She mentioned 82% of respondents typically drive alone; 6% typically carpool; 8% of respondents primarily use active transportation methods and of these, 78% are residents of Hamilton County. Also, 3% of respondents primarily use public transportation and most of these respondents live in Hamilton County with a significant number in Boone, Campbell, and Kenton counties as well. The top concern for those that commute by bus in Hamilton County is the lack of public transportation options with traffic and congestion the top concern for other counties.

She also reported on the transportation priorities that respondents felt were very or extremely important across the region; to maintain current transportation infrastructure (80%); improve walkability and pedestrian infrastructure (73%); improve connectivity within the OKI region (70%) and expand public transit (63%) of these results Hamilton County respondents 85% felt this way. She also mentioned localized priorities include bicycle Infrastructure: Boone (55%), Hamilton (66%), Kenton (61%) and that adding capacity was also important except to Hamilton County respondents.

To wrap it up she reported that new/future transportation modes likely to be used consisted of; Bus Rapid Transit (BRT); Electric Bicycle and Electric Car.

OKI CONGESTION MANAGEMENT PROCESS: 2024 FINDINGS AND ANALYSIS

Mr. Brett Porter, on OKI's congestion management process: 2024 findings and analysis. He mentioned the transportation planning process in a Transportation Management Area (TMA) shall address congestion management through a process that provides for safe and effective integrated management and operation of the multimodal transportation system, based on a cooperatively developed and implemented metropolitan-wide strategy, of new and existing transportation facilities using travel demand reduction and operational management strategies.

The CMP Findings and Analysis Report documents the methodology and findings of evaluating traveltime information for the OKI region's Congestion Management Network, as well as forecasted congestion levels for 2050.

FY24-27 TRANSPORTATION IMPROVEMENT PROGRAM/ADMINISTRATIVE MODIFICATION #10

Mr. Andy Reser, OKI Staff, administrative modification #10 includes minor funding and timing changes to six highway projects and one transit project. The Village of Williamsburg requested an additional 10% OKI-TA funds for Main Street Shared Use Path project. He mentioned Federal railroad crossing funds went to the Little Miami Scenic Trail Crossing Signal project in Loveland, which also has OKI-TA funds. In Kentucky, funding revisions for two Boone County/OKI funded projects. And in Indiana two District-wide projects for Lighting and Pavement Markings were moved from FY24 to FY25. For transit, Butler County RTA's Oxford planning study was moved to FY25.

Ms. Henderson moved to approve TIP Administrative Modification #10. Mr. Franxman seconded the motion, motion carried.

FY24-27 TRANSPORTATION IMPROVEMENT PROGRAM/AMENDMENT #8

Mr. Andy Reser, OKI Staff, amendment #8 includes the addition of twenty projects. Eight projects are added which were recently awarded OKI Carbon Reduction Funds for EV Charging Infrastructure. These EV Charging projects are in Fairfield, Trenton, Butler County MetroParks, Anderson Township, Cincinnati, Forest Park, Boone County and CVG. We are also adding an INDOT project for a portion of the I-275 Carrol Cropper Bridge Repair. On the transit side, OKI-5310 projects have been added to the TIP. The FY 2025 5310 projects are split into FTA line items for subrecipient replacement vehicles, vehicle equipment, preventative maintenance, software, contracted services, mobility management and program administration. TANK is a direct recipient and 5310 funds for operating assistance are also added.

Mr. Wright moved to recommend approval of Resolution 2024-17 Concerning Amendment #8 of the Fiscal Years 2024-2027 Transportation Improvement Program to the OKI Executive Committee. Mr. McDonel seconded the motion, motion carried.

OTHER BUSINESS

Mr. Goetzman, Chair, reminded ICC members to get their membership forms into Regina Fields by Monday, May 20.

Mr. Goetzman, Chair, announced a virtual public meeting on the 2050 Metropolitan Transportation Plan will be Monday, June 10 at 4 PM. You can also visit the website <u>2050update.oki.org</u>

Mr. Reser, OKI Staff, announced the STBG/CMAQ/SNK/TA applications are due June 7 by 4 PM.

Mr. Koehler, Deputy Executive Director noted that communities receiving federal transportation grants from the Bi-Partisan Infrastructure Law (BIL), such as, safe streets for all funds, need to be included in the OKI TIP.

Mr. Johnston reminded everyone that May is bike month with next week being bike week. Breakfast on the Purple People Bridge will be held Friday, May 17.

EXECUTIVE COMMITTEE ACTIONS

Executive Committee Meeting Minutes Ohio-Kentucky-Indiana Regional Council of Governments May 9, 2024 – 10:30 a.m.

Attendance record for OKI board members along with guests and staff follow the minutes.

Item #1A - Administrative

OKI First Vice President Josh Gerth called the meeting to order at 10:32 a.m. He reminded members to sign in and silence their cell phones. Additionally, he noted today's meeting is an executive committee meeting, and only members (of the executive committee) or their alternates may vote or second a motion. He asked that members state their name clearly when making a motion or second so it could be captured in meeting minutes. FVP Gerth asked Judge Executive Kris Knochelmann to lead the Pledge of Allegiance.

Item #1B - Approval of the April 11, 2024 Board of Directors Meeting Minutes

FVP Gerth requested approval of the April 11th Board of Directors meeting minutes as distributed. Commissioner David Painter moved that the minutes be approved, Mr. Ken Reed, Treasurer seconded; motion passed unanimously.

Item #1C - CEO's Report

Mr. Mark Policinski stated there is a northern Kentucky organization called the Devou Foundation and they are in the process of gathering signatures to place on the city of Cincinnati's November ballot an amendment to the city's charter. The amendment would prohibit the city of Cincinnati from belonging to an MPO (Metropolitan Planning Organization), i.e., OKI, who does not have proportional voting by population.

He said it is very important for everyone to understand that this amendment is not sponsored by the city of Cincinnati.

He continued and said the Devou effort is called Fair Share for Cincinnati and that the campaign is built on two misrepresentations. The first misrepresentation is because of the voting structure of OKI and how the Board has voted over the years, the city is not getting its fair share of the amount of funds that OKI expends in Ohio. The second misrepresentation is that the projects that the Board has approved over the years are not the projects that the city of Cincinnati wanted.

Mr. Policinski said the city of Cincinnati is about 18.5% of the Ohio population in the OKI region. From 2010 to 2028, the city has received 31% of all the Ohio funds expended by OKI. In direct grants, where the city was the primary applicant, \$143 million, roughly about 18%. He also mentioned there are other grants approved by the Board where the city is a direct beneficiary but not the primary applicant, such as projects at the Banks, the Western Hills Viaduct, and the Martin Luther King interchange. He said without the Board approving of the unique financing plan, there would be no Martin Luther King interchange, which has yielded about a \$3 billion investment in the Uptown area. Continuing, he said the Board has extended about \$115 million to SORTA; of which 62% of the ridership and 62% of the routes of Metro are in the city of Cincinnati. All of this has been done by working hand in glove with the city of Cincinnati. He further said Devou is saying, "well these are not really the projects that the City of Cincinnati wants." Mr. Policinski stated for at least the past 20 years that he has been CEO; OKI does not put projects in your jurisdiction. The jurisdictions propose the projects to OKI. OKI has never gone to a jurisdiction and told them what projects they will propose, and which OKI will fund.

Mr. Policinski then invited Mr. Aaron Herzig with Taft Law to the podium.

Mr. Aaron Herzig introduced himself and stated that Taft Law has been the law firm of record for OKI for decades. He shared some history about the governance of OKI via comments and a PowerPoint presentation.

Mr. Herzig provided various scenarios as follows:

- Could OKI be forced to change its governance structure if this charter amendment passes? The answer is no. Cincinnati's charter doesn't govern OKI. None of the local jurisdictions or local governments could pull down OKI as a corporate entity.
- Could the city of Cincinnati leave OKI? No, it's not a member, so it can't leave something it's not a member of.
- OKI is the MPO for the region. The three states (OH, KY, IN), the federal government and federal law prefer one MPO for a region.
- Could Cincinnati stop participating in the decision making of OKI? It could. If the City of Cincinnati charter is amended and it says do not participate in an MPO, the city may not be able to participate. That's a decision for the city to make.

Mr. Policinski stated Devou Foundation is well-financed with a strong social media presence. He wanted Board members to have the facts to share with their communities.

Mr. Policinski asked if there were any comments or questions.

Judge executive Steve Pendery asked if there is enough time for the Devou Foundation to read our materials and begin understanding what they are proposing is a waste of time such that they can change their proposed charter amendment.

Mr. Policinski responded by saying the Devou Foundation is not looking for a compromise.

Council Member Mark Jeffreys thanked Mr. Policinski for his time working on this issue. He reiterated that this is not from the city of Cincinnati. He did ask the city for a legal opinion several months ago. He stated the city has real problems to solve and this is not one of them nor is it a good use of the boards' time; it's a solution in search of a problem that does not exist. He secondly stated that the city of Cincinnati and city council has approved every single project that they applied for from OKI. He will ask the city for a formal report and share that with his colleagues. He said they can't prevent a private citizen from putting an issue on the ballot. The amendment is not in the interest of the city.

Commissioner Denise Driehaus, Hamilton County stated the city of Cincinnati is critical to Hamilton County. They are always in partnership with the City of Cincinnati. She noted she has a great deal of respect for Councilmember Jeffreys as he is engaged in this group as he is with many things related to transportation. She stands in solidarity with the city of Cincinnati in saying this is a solution in search of a problem. She stated there is no problem, we saw the numbers and the city is clearly getting its fair share and that the projects are things they have asked for and what they want. She said it is misguided and that is the perspective from herself representing Hamilton County.

Commissioner Steve Hayden, Covington asked do we know what instigated the launch of this effort. Mr. Policinski responded he does not know.

Mayor Elizabeth Slamka, Middletown asked what OKI is doing in getting the truth out to the community despite DeVou's strong social media presence and budget. Mr. Policinski responded OKI cannot expend money to lobby. All OKI can do is present the facts, be active on social media and, if contacted, we will talk about this amendment. OKI cannot launch a lobbying effort. It would be a misuse of public funds. However, he said OKI will be vigorous in getting the facts out.

Council Member Susan Vaughn, City of Hamilton asked if the PowerPoint will be available, and the answer was yes.

Commissioner T.C. Rogers, Butler County added that OKI has been running well. He said this is a threat, but he will remain a strong supporter of OKI.

Mr. Herzig reiterated that OKI cannot set up a campaign committee, but that OKI can combat misinformation and tell the public what is accurate and true. He said the Board of Directors in their roles as elected officials, as individuals and citizens can say what you want, where you want about an issue of public interest, same for OKI staff.

Mr. Policinski provided final comments stating what OKI has done over the past 20 years, is invest tens of millions of dollars of projects annually. The board of directors approve hundreds of millions, without "no" votes. We work across states and party lines and build projects that are needed, and we always have cooperation and communication. OKI is magnificent and it is being attacked with a misinformation campaign.

Item #1D – Finance Officer's Report

Director of Finance, Ms. Katie Hannum, stated copies of the Finance Officer's Report were distributed to all in advance with a printed copy at their seats. Ms. Hannum reported the Council's financing activities, as of May 3, 2024, OKI had:

\$674,926 in the PNC Bank Commercial Checking Account \$26,685 in the PNC HAS/FSA Checking Account \$875,821 in the STAR Ohio Money Market Mutual Fund Account

Ms. Hannum reported there has been no recent activity on OKI's line of credit, and that there is no outstanding balance at report date. She further reported on Balance Sheet, Revenue and Expense information.

FVP Gerth requested a motion to approve the financial report. Mr. Darryl Haley, SORTA provided a motion, Mr. Ken Reed, Treasure seconded the motion; motion passed unanimously.

Item #2 – Ohio EPA & Ohio DNR Regional Water Studies Overview

Guest speaker, Ms. Tiffani Kavalec, Policy Director Ohio EPA provided an overview of Ohio's 15county regional water study for Central Ohio. She outlined the current study and shared that a 17-county regional water study for SW Ohio is coming next.

Highlights of her presentation include Columbus being the fastest growing city in the country, much aided by the recent manufacturing investments from Intel, Hyperion, and the Honda/LG plant – all of which are using large volumes of water daily. Additionally, Columbus also has one of the fastest growing locations for data centers with Amazon Web Services announcing nearly \$8b further investment in Ohio on top of a \$6.3b investment. She noted that water reuse, how they treat wastewater effluent to a higher standard than stream water quality standards. She showed a screenshot of a Regional Water Study dashboard for Central Ohio which provides historical data, projected data and total water use by county. She noted they are still in the data gathering stage and she shared multiple data maps, such as water wells, streams, and ambient ground water monitoring. She mentioned the WateReuse committee and encouraged the board of directors if they were interested in participating to contact her. She expects the Central Ohio project to be completed by December 2024 and SW Ohio request for proposals will be later this summer.

Item #3 – Resolution Authorizing the Marketing Campaign for the Regional Clean Air Program

Ms. Jenny Newcomb, OKI staff explained that OKI is the eligible grant recipient for federal assistance to undertake the region's Clean Air program. OKI partners with several media outlets and businesses to effectively promote the 'do you share for clean air' message throughout the region. She requested a resolution to establish authorization for the marketing expenditures for the FY 2025 Clean Air program. FVP Gerth requested a motion to approve Resolution 2024-13. A motion was provided by Councilmember Mark Jeffreys, with a second from Judge Executive Kris Knochelmann; motion passed unanimously.

Item #4 – Resolution Authorizing the Marketing Campaign for the Regional RideShare Program

Ms. Jenny Newcomb, OKI staff shared that the OKI RideShare program serves as the Local RideShare Agency (LRA) for OKI's eight-county region. The goal of the program is to reduce single occupant vehicles on the roadways by providing commuters with alternative forms of transportation such as carpooling or vanpooling. She stated the purpose of this resolution is to establish authorization for the marketing expenditures for FY 2024 RideShare campaign. FVP Gerth requested a motion to approve Resolution 2024-14. A motion was provided by Councilmember Susan Vaughn with a second from Mr. Roger Kerlin; motion passed unanimously.

Item #5 – SFY 2025 Ohio Water Quality Areawide Funding Agreement TIPBUD

Mr. David Rutter, OKI staff stated the SFY 2025 Ohio EPA areawide water quality planning agreement includes \$75,000 of state pass-through funds from the state Biennium Budget.

(Continued Item #5)

OKI will develop a scope of services which details the water quality management planning activities that it will undertake in Ohio and not exceed \$75,000.FVP Gerth asked for a motion for Resolution 2024-15, which was provided by Commissioner David Painter and seconded by Mayor Elizabeth Slamka, motion carried unanimously.

Item #6 – SFY 2025 Ohio Water Quality Areawide Funding Agreement 604(b)

Mr. David Rutter, OKI staff stated that the FY 2025 Ohio EPA Areawide water quality planning agreement included federal pass-through funds in an amount of \$99,028.57 under Section 604(b) of the federal Clean Water Act. OKI will develop a scope of services which details the water quality management planning activities that it will undertake in Ohio during SFY 2025 and not exceed the above stated amount. FVP Gerth requested a motion to approve Resolution 2024-16. Commissioner Steve Hayden provided the motion with a second Councilmember Susan Vaughn; motion carried unanimously.

Item #7 - Intermodal Coordinating Committee Report

OKI staff, Mr. Andy Reser provided a brief update on the ICC meeting held on May 72024. He shared that the following persons provided presentations: Fred G'Sell, ETC Institute presented the results of the OKI Transit Onboard survey, Dr. Elizabeth Niese, OKI staff presented findings from the 2050 Plan online survey and Brett Porter, OKI staff shared the 2024 Congestion Management Process Report. Mr. Reser added that the ICC approved administrative modification to the TIP. Lastly, the committee was reminded of the June 7 deadline to submit applications for OKI STBG/SNK/TA and Carbon Reduction transportation funds and made a recommendation to the executive committee to approve TIP Amendment #8.

Item #8 - Amendment #8 of the OKI Fiscal Years 2024-2027 Transportation Improvement Program

Mr. Andy Reser, OKI staff stated that Amendment #8 includes the addition of twenty projects. Of which, eight were added due to their recent award of the OKI Carbon Reduction Funds for the EV Charging Infrastructure. The EV charging projects are in Fairfield, Trenton, Butler Co. MetroParks, Anderson Township, Cincinnati, Forest Park, Boone Co. and CVG Airport.

Additionally, an INDOT project was added - a portion of the I-275 Carol Cropper Bridge repair. Mr. Reser continued with updates regarding transit, including 5310 projects that were added to the TIP. He noted FY 2025, 5310 projects are split into FTA line items for subrecipient replacement vehicles, vehicle equipment, preventative maintenance, software, contracted services, mobility management and program administration. TANK is a direct recipient and their 5310 funds

FVP Gerth requested a motion to approve OKI Resolution 2024-17. A motion was provided by Trustee Shannon Hartkemeyer with a second from Mr. Roger Kerlin; motion passed unanimously.

Item #9 - Other Business

There was no other business from the floor. FVP Gerth reminded everyone the next meeting is June 13th, a Board of Directors meeting starting at 10:30 a.m.

FVP Gerth requested a motion to adjourn, which was provided by Treasurer Ken Reed with a second from Mr. Karl Schulz; motion passed unanimously. End of meeting 11:36 a.m.

Staff presented a TIP Administrative Modification and a TIP Amendment to the ICC. The TIP Amendment was presented to the Executive Committee for approval. A draft TIP Administrative Modification and TIP Amendment were prepared for June.

Staff responded to questions regarding the 2024 Project Prioritization Process and assisted applicants as needed.

Alternative fuels coordination and advancement: NEVI program roll out for each state continues. Ohio was the first state to release its RFP for projects and recently opened the nation's first NEVI funded DCFC. Kentucky closed its second round of NEVI funding on April 18 and will announce selected locations later in 2024. Staff are coordinating with applicants awarded Carbon Reduction Program funds in Ohio and Kentucky. Staff continue to provide input to state DOT partners and Duke Energy on Alternative Fuels Corridor Plans. Staff continue to monitor existing EV charging station usage in the OKI region. OKI's second round of CRP funding opened on March 12 and closes on June 7.

SORTA/Cincinnati Metro – May 29, 2024: Attended the public meeting at the Price Hill Public Library to hear a summary presented by Metro staff about proposed service improvements that will take effect in August 2024.

Community Council Meetings – May 6, 7, 8, 9, 15, 16, 21 and 28, 2024: Staff attended the monthly community council meetings to monitor any on-going transportation concerns or issues in Clifton on May 6th and in Sedamsville on May 8th.

On May 7th at the Pleasant Ridge Community Council meeting a representative from the community's Pleasant Streets Committee reported on traffic calming efforts for 2025 in response to requests from the city of Cincinnati. The committee is recommending that the community submit the speeding and vehicular turns that occur at the intersection of Montgomery Road and Ridge Avenue, that occur at the intersection of Woodford Road and Ridge Avenue near Nativity School and that occur on Montgomery Road at Ridge Avenue down to the Walgreens Drugstore. The community is also asking the city to consider scrambling the lights at the "Triangle" and to consider adding more speed cushions. The committee representative also reminded attendees that Ridge Avenue is up for a redesign and staff from the city's Department of Transportation & Engineering will be invited to attend the August meeting.

At the Walnut Hills Area Council meeting on May 9th personnel with SORTA/Cincinnati Metro provided an update regarding the transit center proposed on the one acre of land at Gilbert Avenue and William Howard Taft Road. The representative reported that the NEPA analysis has been completed and the project is now in the acquisition phase. Additionally, an RFP has been released for ideas and it's now time

for the Walnut Hills community to convene a steering committee. The SORTA/Cincinnati Metro personnel also noted they hope to work on the project's design over the next nine months. The proposed design includes (6) bays for buses, an 8-car Park 'N Ride area with (2) EV charging stations, a Red Bike and scooter docking area, an area to pick up packages from Amazon and the capacity to charge buses in the future if the fleet of buses should switch to electric buses. City of Cincinnati personnel from DOTE noted that with the onset of the proposed transit center bus Route #11 may have minor changes with its bus stops and crosswalk, especially if additional analyses so indicate.

On May 15th at the Mt. Washington council meeting the representative from Sands Montessori School shared information asking that a letter of support be sent to Cincinnati City Council requesting that a crosswalk be created on Corbly Avenue near the school to improve pedestrian safety, especially for the school children. Another possibility could be the use of community artwork on the crosswalk to address the concern.

On May 16th at the Madisonville Community Council meeting the Transportation Committee chairperson reported on the results of the Madisonville Community Council's Traffic Calming Survey. As a result of that update attendees voted for traffic calming to occur on Madison Road from Whetsel Avenue to Stewart Avenue as their #1 choice for next year. The chairperson also reported that a raised crosswalk will be installed in front of Bramble Park this summer and that funding has been approved for a raised crosswalk to be installed in three years at the intersection of Anderson Place and Madison Road.

At the Avondale Community Council meeting on May 21st Cincinnati Police Officer Isaacs with District #4 reported that he'll be volunteering in June and July to conduct a 10-week class at Hirsch Recreation Center to teach youngsters how to build new bikes.

On May 28th at the Mt. Airy Town Council meeting Councilmembers Mark Jeffreys and Anna Albi shared information on their respective areas of focus. Councilmember Jeffreys spoke regarding his passion relative to pedestrian safety and the (3) areas in his belief to improve pedestrian safety – education, enforcement and engineering. He acknowledged that he's also concerned about the significant increase in property taxes and the potential impact on Cincinnati residents. He noted the need to influence at the state level since that is where the tax rates are determined/controlled. Councilmember Albi spoke regarding her passion for working to improve gun safety and gun legislation. She reported that 40% of guns being stolen are stolen out of cars so she's working on the need for increased gun locks and continuing to work with victims of gun violence as well victims of domestic violence through the Women Helping Women program. She acknowledged that she's concerned about the need for a fair, livable wage to ensure families can afford healthy food and quality housing and hopes to address "food deserts" and mental health concerns. Both councilmembers took questions from the floor regarding "Connected Communities" and explained that the concept is connected to mass transit as a result of the levy that passed which now provides Cincinnati Metro the funding to implement Bus Rapid Transit. In response to a request from the city of Cincinnati attendees at the council meeting agreed to recommend that the city monitor signage on Kipling Avenue and install speed cushions along Shepherd Creek Road and Colerain Avenue.

The consultant is working jointly with Planning Communities, the subcontractor, to create an informative fact sheet for the OD survey. This is expected to be delivered to OKI in early June.

Staff met with Enterprise for update on potential vanpool leads.

Staff submitted CMAQ application and was approved for funding.

Staff received 1 inquiry about vanpooling, which was forwarded to Enterprise.

Section 5310 Program (674.3)

Staff worked on submitting latest grant in TrAMS.

Staff is continuing to review and follow up on monitoring questionnaires and vehicle monitoring reports.

Section 5310 Program Pass Through (674.4)

In May, staff approved invoices for CABVI, Clermont Senior Services, SORTA and Transit Alliance of Butler County.

Ohio Exclusive: Transportation Planning Activities (684.3)

Classified traffic counts and vehicle occupancy counts at select Ohio locations - The OKI Board approved the selection of DLZ National for the traffic data collection contract. Field work continues. Data collection for bike/ped counts was completed. Same for vehicle occupancy. Volume count collection was 90% completed as of the week of May 17. The remaining volume locations will be completed by June 30, 2024. Spring season started early February 2024. The consultant purchased 60 new HI-STAR units and revamped their current RADAR units to combat the delay caused by weather and software issues earlier in the season.

Fully functioning next generation ORBCS count station(s) at one Ohio River bridge location – Two bids were received for an AI camera-based count station in the vicinity of the Combs-Hehl bridge. Staff selected the vendor with the lowest qualified bid. A notice to proceed will be given following approval by the OKI Board in June.

Access to observed travel data through financial participation in ODOT's travel data purchase – OKI was granted access to the Streetlight platform for all OKI counties without cost to the agency from ODOT.

The consultant has evaluated the drainage area and storage volumes for the 159 basins from the previous step and has begun developing the criteria to select the basins for physical surveying. After the latest meeting with the consultant it was determined that an extension of the timeline for completion to September would improve the selection process and surveying of the selected basins. Staff also converted the impervious surface layer from a raster format to polygons to aid the consultant's GIS analysis of basin drainage areas.

Housing Dashboard and Workshop – Work continues on the Housing Dashboard. A dashboard mockup with data components was prepared. April 17 staff met with consultant team to review draft dashboard data visual presentations and began to prepare content to accompany the data.

Indiana Exclusive – Dearborn County (685.1)

(400) Transportation Performance Measures: OKI supports INDOT's targets. Staff continues to monitor the OKI Performance Measures and the OKI Performance Measures website.

(400) 3C Planning Process: Staff continues to coordinate with Dearborn County and INDOT personnel in support of Dearborn STP, HSIP, CMAQ and TA projects. Staff attended the Indiana MPO Council Meeting on May 23.

Staff continue to provide input to state DOT partners and Duke Energy on NEVI and Alternative Fuels Corridor Plans. Staff are monitoring existing EV charging station usage in the OKI region. OKI's second round of CRP funding closes on June 7.

Link 101: No activity. Project has been terminated.

(300) Participation in non-motorized Y410 transportation planning activities including multi-use path shape file and inventory. Evaluation of bike/ped MTP projects is complete. Some are included in the draft MTP project list. Update of bike/ped safety data continued.

(400) Performance Measures and Safety – Ongoing TPM dashboard maintenance.

(300) Air Quality: AQ conformity was completed for the Draft 2050 OKI MTP.

(400) Coordinated Plan and 5310 Projects: Grant management is on-going. TRAMS reporting continues. Transit TAM updates continued.

(300) ADA and advancement towards connected communities and ladders of opportunity. Technical service to local governments: No activity this period.

(400) FC, HPMS, CMP and ITS-A: CMP intersection LOS complete. Urban boundary adjustment was completed and provided to INDOT in October. Approved by FHWA in March. Development of the CMP report continues.

in the OKI region. Staff continued collection of Electric Vehicle Supply Equipment utilization data for future analysis.

BACKGROUND: Over the past several months, staff has presented portions of the 2050 OKI Metropolitan Transportation Plan Update. The update of the OKI 2050 Metropolitan Transportation Plan is now complete and is presented for OKI Board of Directors' consideration. The complete plan with project recommendations is available at <u>https://2050update.oki.org/</u>.

> The OKI region is composed of eight counties in three states – Butler, Clermont, Hamilton and Warren counties in Ohio; Boone, Campbell and Kenton counties in Kentucky; and Dearborn County in Indiana. Transportation planning is undertaken for all eight OKI counties.

> The OKI 2050 Metropolitan Transportation Plan Update serves as a blueprint projecting the transportation needs of the OKI region area for the next 25 years. The Plan Update includes revisions due to technology, infrastructure, environment, and fiduciary changes. At the same time, it responds to Federal Highway Administration, Federal Transit Administration and Clean Air Act requirements that call for a performancebased planning process for mitigating congestion, addressing air quality, and other environmental, social and financial issues. This Plan meets all metropolitan planning requirements stipulated in USC 23 and USC 49.

WHEREAS, the Bipartisan Infrastructure Law (BIL) requires that all transportation plans and programs in urban areas of more than 50,000 populations be prepared by the metropolitan planning organization (MPO) based on a continuing, comprehensive transportation planning process carried on cooperatively between state and local communities; and

WHEREAS, the MPO refers to a forum for cooperative transportation decision-making for the metropolitan planning area and OKI is the designated MPO for the counties of Butler, Clermont, Hamilton, and Warren; Boone, Campbell, and Kenton; and Dearborn by the states of Ohio, Kentucky and Indiana, respectively; and

WHEREAS, OKI in conjunction with local and state representation has prepared an updated metropolitan transportation plan, entitled OKI 2050 Metropolitan Transportation Plan Update as part of the transportation planning process; and

WHEREAS, OKI has employed a year-long layered approach to public outreach which has included 24/7 availability of all Plan materials via a dedicated website, strategic and direct e-mail communications, active social media communications, participation at community-wide civic events in the planning area, a public hearing, and presentation and deliberation of the OKI 2050 Metropolitan Transportation Plan at fourteen OKI member meetings; and

WHEREAS, the impacts of this plan have been considered in accordance with "Executive Order 12898 Federal Actions to Address Environmental Justice in Minority Populations and Low Income Populations"; and

WHEREAS, the ozone maintenance area consists of the Ohio counties of Butler, Clinton, Clermont, Hamilton and Warren; and a portion of the Kentucky counties of Boone, Campbell and Kenton, and a portion of Dearborn County, Indiana; and are subject to transportation conformity rules; and

WHEREAS, the OKI 2050 Metropolitan Transportation Plan Update includes revisions due to technology, infrastructure, environment and fiduciary changes, includes projects that are subject to transportation conformity requirements and a new conformity determination is required based on a new regional emissions analysis, and OKI has engaged in interagency consultation with federal, state and local partners, including the U.S. Department of Transportation, and those partners have concurred with the methodology used by OKI to determine conformity; and

WHEREAS, the projects and programs in this performance-based plan result in a plan that conforms to all applicable U.S. Environmental Protection Agency (EPA) approved State Implementation Plans for air quality consistent with the region's air quality goals, is fiscally constrained, and meets BIL planning requirements; Now, therefore,

BE IT RESOLVED, that the Board of Directors of the Ohio-Kentucky-Indiana Regional Council of Governments at its public meeting of June 13, 2024 adopts the *OKI 2050 Metropolitan Transportation Plan Update* and recommends that its members incorporate the plan recommendations into planning and implementation of transportation improvements for their respective governmental units.

- **BACKGROUND:** Traffic data is a key element in the analysis of existing conditions and the validation of OKI's Travel Model. Traffic data is also required for corridor studies and engineering analyses.

OKI currently owns and operates radar traffic data collection units at the seven Ohio River Bridges in the OKI region. Currently the radars at one of the count stations consistently experience seasonal power issues. OKI seeks to purchase two (2) Video-based traffic counters to replace the existing, radar-based counters at the I-275 Combs Hehl bridge.

The purchase is scheduled to be made on June 14, 2024.

- AUTHORITY: The By-Laws permit the Council to engage the service of consultants to assist in accomplishing the objectives of the Council.
- **FUNDING**: Equipment purchase is funded with Ohio Planning funds in cooperation with the Ohio Department of Transportation (UPWP element 684.3).

AMENDMENT #9 OF THE OKI FISCAL YEARS 2024-2027 TRANSPORTATION IMPROVEMENT PROGRAM

DESCRIPTION: The attached exhibit, in resolution form, describes the specific revision proposed. **BACKGROUND:** OKI is responsible for preparing biennially a four-year program of projects in this region that will make use of available Federal-Aid Highway funds and Federal Transit Administration funds. Inclusion in this program is a prerequisite for such federal assistance. Because the scope, cost, and timing of the included projects are subject to change, and because new projects are continually being developed, the TIP is periodically amended as needed. The amendment reflected in the proposed resolution includes the addition of seven highway, planning, and transit projects. All projects are exempt from air quality conformity requirements. Prior to presentation to the Board of Directors, the proposed amendment is posted to the OKI website for at least 14 days and public comments are accepted. Staff presents the amendment to the Intermodal Coordinating Committee (ICC), the ICC considers the issue, and makes a recommendation to the Board of Directors. Any public comments will be presented to the Board of Directors prior to scheduled action. **AUTHORITY:** 23 CFR, §450.324. FUNDING: The fiscally constrained items proposed for the amendment have an associated funding amount and source specified. Staff has determined that there is adequate funding available, or anticipated to be available, and the funding amounts are shown in year of expenditure figures for this project. **ACTION RECOMMENDED:** Adoption of Resolution OKI 2024-24. EXHIBIT: Resolution (OKI 2024-24) Concerning Amendment #9 of the OKI Fiscal Years 2024-2027 Transportation Improvement Program.

CONCERNING AMENDMENT #9 OF THE FISCAL YEARS 2024 – 2027 TRANSPORTATION IMPROVEMENT PROGRAM

WHEREAS, the Ohio-Kentucky-Indiana Regional Council of Governments (OKI) is designated as the Metropolitan Planning Organization (MPO) by the Governors of Ohio, Kentucky and Indiana acting through the Ohio Department of Transportation (ODOT), the Kentucky Transportation Cabinet (KYTC) and the Indiana Department of Transportation (INDOT) and in cooperation with locally elected officials in the OKI region; and

WHEREAS, the Intermodal Coordinating Committee (ICC), as the technical advisory committee to OKI, has reviewed and recommended the projects and phases listed in the resolution and recommend that they be amended into the Transportation Improvement Program (TIP); and

WHEREAS, all federally funded transit and highway projects in the Ohio Counties of Butler, Clermont, Hamilton and Warren, the Kentucky Counties of Boone, Campbell and Kenton and the Indiana County of Dearborn must be included in the TIP prior to the expenditure of federal funds and be listed with year of expenditure dollars; and

WHEREAS, the amendments are consistent with the OKI 2050 Metropolitan Transportation Plan as amended on September 14, 2023 and the OKI Regional ITS Architecture adopted on September 8, 2022; and

WHEREAS, all projects included in *Amendment 9 – Fiscal Years 2024-2027 Transportation Improvement Program* are exempt from transportation conformity requirements for air quality; and

WHEREAS, the opportunity for public participation has been provided per OKI's Public Participation Plan; and

WHEREAS, the environmental justice impacts of these amendments have been considered with "Executive Order 12898 Federal Actions to Address Environmental Justice in Minority Populations and Low Income Populations"; and

WHEREAS, this amendment will result in a TIP that remains fiscally constrained: Now, therefore,
